- Addressing the incorrect Innovation, Science and Economic Development Canada (ISED) National Broadband Internet Service Availability Mapping that shows specific areas of Wainfleet having 25/5 Mbps internet services available, while in reality, internet service providers (ISPs) in the area are only able to deliver average service speeds in the range of less than 2.5/0.2 Mbps upload;
- Encouraging ISPs to bid for, supply and deliver improved internet services to Wainfleet residents in keeping with Canada's Connectivity Strategy (High-Speed Access for All), particularly in those areas of the Township where even basic 5 Mbps/1 Mbps universal broadband coverage levels are not being adequately provided;

AND THAT copies of this resolution be shared with SWIFT, including the Chief Executive Officer, Board Chair and Regional SWIFT Board Representative Councillor Robert Foster, ISED, the Canadian Radio-television and Telecommunications Commission (CRTC) and the Ontario Ministry of Infrastructure."
