Re: Results of 2022 Municipal Elections

Voting Day for the 2022 Municipal Elections was October 24, 2022. Unofficial results were publicly posted following the close of voting. In accordance with Sections 55(4) and 55(4.1) of the Municipal Elections Act, the final results of the election were certified and posted to the Township's website on October 25, 2022 – as was a Declaration of Election declaring the candidate or candidates, as the case may be, who received the highest number of votes to be elected.

Copies of the certified Elections Summary and Declaration of Election are attached to this memorandum as information.

Certification of Election Results & Declaration of Election

Certification of election results following the close of voting forms a critical part of the duties of the Clerk associated with the conduct of every Municipal Election. As provided for in the Municipal Elections Act, on the day following voting, the Clerk undertakes a thorough review of all election materials and documentation associated with Voting Day activities to ensure completeness and accuracy in accordance with the Municipal Election Act. The certification process is specifically intended to identify and address anomalous situations prior to the final results of the election being confirmed and certified.

During the certification review on October 25, 2022, an anomalous situation was identified. As background: Wainfleet has exclusively utilized a vote-by-mail system since 2014. As such, Wainfleet's vote processes are all centered around electors delivering sealed Return Voting Envelopes to the Township. Each Return Voting Envelope contains a signed declaration of voter eligibility and a sealed Ballot Secrecy Envelope containing the elector's marked ballot and is securely stored in a ballot box upon receipt.

Our vote-by-mail processing procedures provide:

- Upon the opening of a ballot box, sealed Return Voting Envelopes in the box are batched into groups of 25 to provide for manageable processing.
- Processing involves opening each sealed Return Voting Envelope, scanning the signed declaration of voter eligibility to record the elector as having voted and then placing the accompanying sealed Ballot Secrecy Envelope (holding the elector's marked ballot) into a Secure Collection Box to be taken to a central ballot counting location for subsequent

- tabulation. Meanwhile, the original signed declarations along with the now-opened Return Voting Envelopes are retained in a separate storage box for audit purposes.
- This separation of the contents of Return Voting Envelopes into 2 streams (the first one being the elector's signed declaration and Return Voting Envelope, and the second being the sealed Secrecy Envelope containing that elector's ballot for future counting) is intended to anonymize the voting process – to ensure that nobody can trace back a specific ballot to a specific elector – thus ensuring the privacy and secrecy of each elector's vote.

During the review of all of our materials as part of the certification process, staff located one batch of 25 time-stamped and unopened Return Envelopes filed in one of the storage boxes containing the already-processed declarations and Return Voting Envelopes. In those same storage boxes containing the already-processed declarations and Return voting Envelopes, staff also located a further 4 time-stamped and sealed Ballot Secrecy Envelopes that had not been transferred into a Secure Collection Box to be taken to a central ballot counting location.

The accuracy and validity of the ballots that were processed on Voting Day was not in question – but it was determined that there were 29 electors that had legitimately cast their ballots prior to 8:00 pm on Voting Day – and their votes were not originally counted.

As those ballots were legally returned to the Township prior to the close of voting at 8:00 pm on Voting Day – those ballots needed to be counted. A special count was therefore undertaken at 6:00 pm on October 25, 2022, in the same manner and using the same procedures that were utilized on Voting Day - and the totals from that special count were added to the totals from Voting Day's tabulated results to provide a final count of votes cast for each candidate.

All candidates were notified of the situation and were invited to attend to observe special count at 6:00 pm. In accordance with the Municipal Elections Act, candidates that were unable to attend personally were permitted to send a scrutineer in their place – and we did have a total of 10 candidates/scrutineers in attendance.

Following the special count, staff were able to finalize the certification of election results – and the final results were posted to the Township's website following the special count (copy attached).

In closing, staff would note that, when results are displayed on election night, every municipality includes a disclaimer on those results that they are "unofficial until certified by the Clerk". The reason for this disclaimer is so that the certification process contemplated by the Muncipal Elections Act can be undertaken to carefully audit Voting Day processes, materials and documentation to ensure that every elector's vote is properly accounted for. In certifying the results on October 25, 2022, I am confident that the Township has achieved that: each elector's vote was properly recorded.

Restricted Acts after Voting Day

At its meeting of February 15, 2022, Council considered Report ASR-005/2022 from the Deputy Clerk regarding restricted acts of Council either after Nomination Day and/or after

Voting Day in the case of less than three-quarters (75%) of Members of the outgoing Council returning as part of the new, incoming Council.

At this time, staff would advise that the Restricted Act provisions of the Municipal Act, 2001, are in effect. This means that Council is currently prohibited from taking the following actions:

- (a) the appointment or removal from office of any officer of the municipality;
- (b) the hiring or dismissal of any employee of the municipality;
- (c) the disposition of any real or personal property of the municipality which has a value exceeding \$50,000 at the time of disposal (see *Note*); and
- (d) making any expenditures or incurring any other liability which exceeds \$50,000 (see *Note*).

Note: Clauses (c) and (d), above, do not apply if the disposition, expenditure or liability was included in the most recent budget approved by Council before Nomination Day in the election.

Staff would note that, prior to the lame duck period, Council did enact a by-law (By-law No. 010-2022 at the above-noted Council Meeting of February 15, 2022) delegating authority to the Chief Administrative Officer to approve some of these restricted acts should circumstances warrant. In the event that such actions are taken by the CAO, the exercise of such delegated authority would be reported to Council as soon as is practicable.

NOW THEREFORE the Council of the Corporation of the Township of Wainfleet **HEREBY ENACTS AS FOLLOWS:**



BY-LAW NO. 046-2022

Being a by-law to adopt, ratify and confirm the proceedings of the Council of the Corporation of the Township of Wainfleet at its regular meeting held September 27, 2022.

WHEREAS Subsection 5 (1) of the *Municipal Act*, 2001, S.O. 2001, Chapter M.25, as amended, provides that the powers of a municipal corporation are to be exercised by its Council;

AND WHEREAS section 5 (3) of the *Municipal Act 2001*, S.O. 2001, Chapter M.25, as amended, provides that, except if otherwise authorized, the powers of Council shall be exercised by by-law;

AND WHEREAS it is deemed desirable and expedient that the actions of the Council as herein set forth be adopted, ratified and confirmed by by-law;

NOW THEREFORE the Council of the Corporation of the Township of Wainfleet **HEREBY ENACTS AS FOLLOWS**:

- (a) The actions of the Council at its regular meeting held September 27, 2022, including all resolutions or motions approved, are hereby adopted, ratified and confirmed as if they were expressly embodied in this by-law.
 - (b) The above-mentioned actions shall not include:
 - (i) any actions required by law to be taken by resolution, or
 - (ii) any actions for which prior Ontario Municipal Board approval is required, until such approval is obtained.
- 2. The Mayor and proper officials of the Corporation of the Township of Wainfleet are hereby authorized and directed to do all things necessary to give effect to the above-mentioned actions and to obtain approvals where required.
- 3. Unless otherwise provided, the Mayor and Clerk are hereby authorized and directed to execute and the Clerk to affix the seal of the corporation of the Township of Wainfleet to all documents necessary to give effect to the above-mentioned actions.
- 4. This by-law shall come into force on the day upon which it is passed.
