**AND WHEREAS** the Council of the Township of Wainfleet recognizes that municipal drains are critical elements of rural infrastructure that support agricultural production, enhance food security and support environmental and economic sustainability in rural Ontario;

**AND WHEREAS** an underlying principle of the Drainage Act of Ontario is that all owners of property that are assessed to municipal drain projects are required to participate in and contribute to such projects; including public utilities such as water works, gas works, electric heat, light and power works, telegraph and telephone lines, railways, street railways and so on;

NOW THEREFORE the Council of the Township of Wainfleet calls on our provincial and federal partners, including the Minister of Transport of Canada, to encourage all railways however operated, including CNR, to engage with the Ontario Ministry of Agriculture and Rural Affairs, the Association of Municipalities of Ontario (AMO), the Rural Ontario Municipalities Association (ROMA), the Drainage Superintendent's Association of Ontario (DSAO), local municipalities, farmers and other stakeholders to uphold the underlying principle of Ontario's Drainage Act that all property owners assessed to municipal drain projects are required to participate in, and contribute financially to, such drain projects; and

**THAT** a letter of support be sent to the local MPP and MPP representatives in Niagara."
